African American forestland owners have been unable to participate in USDA programs for several reasons. One reason has been that they have been unaware of government programs, but another reason is Heir's Properties issues. The AgNR unit knows that the SFLR program can help African-Americans forestland owners address this issue through preventive education and resolution counseling. Therefore, our purpose is to ensure that African American forestland owners are not only profitable but more informed in ways to better position land for retention.

The Sustainable Forestry and African American Land Retention (SFLR) Program helps forestland owners manage their forestland for maximum production. It also offers legal education and direct legal services to help families develop wills, estate planning, and counseling with title clearing, developing trust, agreements and more to help landowners.













## Program Legal Services Overview

The American Forestry Foundation (AFF) has awarded Prairie View A&M University Cooperative Extension Program Agriculture and Natural Resources Unit a two-year grant to help African American forestland owners maintain their forestland.

The law firm of Phillips Kaiser PLLC will assist in providing legal educational workshops and services to assist and educate families in retaining their land.

#### Legal Program - Services Provided

- Free heirs and legacy estate planning outreach workshop outreach meetings will be conducted for each Community Based Organization (CBO) partner
  - One 2–4 hour clinic will be organized for each CBO offering one-on-one heirs, and wills & estate education
- Free estate planning materials
- Simple free wills for landowners that qualify

Participants will receive information for land retention and ways to keep land in their family
